Brexit Latest!

EU leaders formally agreed to start the next phase of Brexit negotiations later.

It means talks can move on to the long-term relationship between the UK and EU, days after Theresa May suffered her first defeat in the House of Commons.

The next round of talks on a transition period after the UK leaves in March 2019 could begin as early as next week. European Commission President Jean-Claude Juncker said this process would be "significantly harder".

Mrs May was applauded by other leaders at dinner in Brussels on Thursday night after she made a speech urging the two sides to embrace the way ahead with "creativity and ambition".

2017/18 Tax Rates

- **Tax-free personal allowance** on income tax to rise to £11,850 in line with inflation in April 2018.
- **Higher-rate tax threshold** to increase to £46,350.
- Short-haul air passenger duty rates and longhaul economy rates to be frozen, paid for by an increase on premium-class tickets and on private jets.
- National Living Wage to rise in April 2018 by 4.4%, from £7.50.

Zakari Asks Members to Embrace Entrepreneurship

ICAN President Isma'ila M. Zakari, mni, FBR, FCA, has implored chartered accountants to look beyond their certificates and embrace entrepreneurship in order to meet the needs of millions of Nigerians.

Zakari made this call at a one-day seminar on entrepreneurship organized for members in Lagos recently. According to him, "entrepreneurship can provide a vehicle for employment generation as well as opportunities for finance, training and development". He however warned that entrepreneurship is a serious business and may not be a bed of roses at the beginning, but with persistence, it would pay off.

He averred, "the economic advancement made by any nation is essentially connected to the effectiveness of its small-scale businesses, which are regarded as the engine room of nations' economies".

Speaking further, he explained that Small and Medium Enterprises (SMEs) could spur significant economic growth because they hold key to sustainable development and the long-term survival of any nation, adding that their contributions to improved living standards bring about substantial capital formation and achieve high level of capacity and productivity.

He said his presidency was focusing on entrepreneurship because of its enormous potentials and advantages for professional accountants to start to manage and successfully grow any enterprise with little or no supervision.

ICAN Inducts 650 New Accounting Technicians

The Institute has admitted six hundred and fifty (650) new accounting technicians under its Association of Accounting Technicians West Africa (AATWA).

The new members admitted at the 47th induction held last week in Lagos brings the number of holders of the institute's AATWA qualification to 22,512.

Awards were also presented to candidates for outstanding performance in the September 2017 diet of the AATWA examination. Mr. Lawal Oluwafemi Moses bagged the overall best candidate award while Ogunmade Gbemisola Olaitan received the overall best qualifying female candidate for the year.

Speaking at the induction, the Chairman of AATWA Executive Committee and Vice president of ICAN, Alhaji Razak Jaiyeola said the accounting technicians scheme which was created in 1989 to provide middle level manpower to the accounting profession in Nigeria has produced competent accounting technicians who have risen from accounting assistant positions to General Managers in their organizations due to outstanding display of intelligence, skill and hard work.
